

LMHP POSITION

We are a private Mental Health Rehabilitation Clinic. Our highly qualified staff includes: Psychiatrists, Licensed Clinical Professionals, and non-licensed Master's and Bachelor level counselors.

We offer comprehensive services to children ages 3 and up, adolescents, adults and families who are experiencing any of the following challenges:

- ADHD and other Cognitive/Learning Disorders
- Depressive Disorder and Bipolar Disorder
- Schizophrenia and other Psychotic Disorders
- Conduct Disorders (often including fighting, bullying, legal problems)
- Generalized Anxiety Disorder
- PTSD and Acute Stress Disorder
- Panic Disorders
- Adjunct support can also be provided for: Autism and Substance Abuse Disorders

The Mental Health Rehabilitation (MHR) Program is administered by the Department of Health and Hospitals through a partnership of the Louisiana Medicaid Program, the fiscal intermediary, the Office of Mental Health, and the network of certified and enrolled providers.

MHR services are for adults with serious mental illness and children with emotional/behavioral disorders. The services are outpatient and designed to reduce the disability resulting from mental illness and assist in the recovery and resiliency of the recipient. These services are home and community-based and are provided on an as needed basis to assist recipients in coping with the symptoms of their illness.

The intent of MHR services is to minimize the disabling effects on the individual's capacity for independent living and to prevent or limit the periods of inpatient treatment. Providers offer prior-authorized services to adults with mental illness and youth with an emotional/behavioral disorder who meet medical necessity criteria for services.

Position Summary:

Licensed Mental Health Professional(s) shall provide counseling, clinical assessment, and clinical supervision of community support workers for chronically mentally ill and/or disabled adults, emotionally disturbed children, or adolescents and their families, to improve quality of life and maintain the highest possible ability to function independently within the community.

LMHP Duties include:

- Provides lead responsibility on MHR assessment team for each assigned consumer in
 which services are rendered. (Includes a minimum of 1 face-to-face interview with the
 recipient and their family/significant other, sign and date the assessment document,
 develop the integrated summary section and sign). Coordination with the primary care
 physician.
- Completes initial assessment as independent assignment without assuming any responsibility for client after authorization has been received.

- Act as team leader of the service planning team, sign and date the ISRP and Quarterly Report.
- Provide crisis intervention services for community support staff as needed.
- Supervises all non-licensed mental health staff that serve as a member of his/her assigned recipients' team, meeting the supervision requirements of the MHR program.
- Coordinates all services for the MHR recipient. This includes but is not limited to the following:
 - Assurance of active recipient involvement in all aspects of care
 - Coordination and management of all services provided through MHR agency
 - Access and coordination of services provided through non-MHR agencies

Education/Experience:

A Licensed Mental Health Professional is a person who has a graduate degree in a mental health-related field from an accredited institution and is licensed to practice in the state of Louisiana by the applicable professional board of examiners. The following professionals are considered to be LMHPs:

- 1. Psychiatrist
- 2. Psychologist
- 3. Registered Nurse
- 4. Social Worker
- 5. Licensed Professional Counselor

Additional required experience:

- At least two (2) years' experience working with children with emotional/behavioral problems and two (2) years' experience working with adults with serious mental illness
- Must complete sixteen (16) hours of post-employment documented orientation training that includes topics outlined in the Louisiana Behavioral Health staffing requirements.
- Must complete twenty (20) hours of annual ongoing education and training that includes topics outlined in the Louisiana Behavioral Health staffing requirements.
